Jesus demonstrated the resurrection of the dead by turning his argument on the tense of a verb. If God was still the God of Abraham, Isaac, and Jacob, then those three must still be alive, he reasoned. This should give us a renewed respect for Jesus, the scholar, and a respect for the authority and inerrancy of scripture itself, if it can hold up to this sort of scrutiny.

Of course, there are major Biblical themes that a grade-schooler can discern -- the milk of the word -but Jesus did not see the pages, or scripture, or even the tense of its words, as the random work of mere men.

How else can men -- and pandas -- learn how they are supposed to behave?

1. What preacher was falsely accused of many things, but confessed to alleged heresy in worship?

Answer: Paul. What Paul believed was truth, not heresy, but he acknowledged that his foes called true worship by the name of heresy. He had been falsely accused of stirring up sedition.

Acts 24:5-6, 10-14 For we have found this man a pestilent fellow, and a mover of sedition among all the Jews throughout the world, and a ringleader of the sect of the Nazarenes: 6 Who also hath gone about to profane the temple: whom we took, and would have judged according to our law. . . 10 Then Paul, after that the governor had beckoned unto him to speak, answered, Forasmuch as I know that thou hast been of many years a judge unto this nation, I do the more cheerfully answer for myself: 11 Because that thou mayest understand, that there are yet but twelve days since I went up to Jerusalem for to worship. 12 And they neither found me in the temple disputing with any man, neither raising up the people, neither in the synagogues, nor in the city: 13 Neither can they prove the things whereof they now accuse me. 14 But this I confess unto thee, that after the

> Dan.6:20 And when he came to the den, he cried with a

lamentable voice unto Daniel: and the king spake and said to Daniel, O Daniel, servant of the living God, is thy God, whom thou servest continually, able to deliver thee from the lions? 21 Then said Daniel unto the king, O king, live for ever. 22 My God hath sent his angel, and hath shut the lions' mouths, that they have not hurt me: forasmuch as before him innocency was found in me; and also before thee, O king, have I done no hurt. 23 Then was the king exceeding glad for him, and commanded that they should take Daniel up out of the den. 6. Who warned military men against making false

Answer: John the Baptist -

Luke 3:14 And the soldiers likewise demanded of him. saying, And what shall we do? And he said unto them, Do violence to no man, neither accuse [any] falsely; and be content with your wages.15 And as the people were in expectation, and all men mused in their hearts of John, whether he were the Christ, or not; 16 John answered, saying unto [them] all, I indeed baptize you with water; but one mightier than I cometh, the latchet of whose shoes I am not worthy to unloose: he shall baptize you with the Holy Ghost and with fire:

in his God. 24 And the king commanded, and they 7. Who shouldn't be accused without verification from others?

Answer: Any man, but in particular, elders. This is an old principle that extends back to the Old Testament.

Deut 19:15 One witness shall not rise up against a man for any iniquity, or for any sin, in any sin that he sinneth: at the mouth of two witnesses, or at the mouth of three witnesses. shall the matter be established. 16 If a false witness rise up against any man to testify against him that which is wrong; 17 Then both the men, between whom the controversy is, shall stand before the LORD, before the priests and the judges, which shall be in those days;

accuse him. 3 And he saith unto the man which had the Romans to deliver any man to die, before that he which is accused have the accusers face to face, and have licence to answer for himself concerning the crime laid against him.
